A. **Subject:** Draft Environmental Impact Report (DEIR) for the Sobrato Phase II

Address: 2111 University Avenue, East Palo Alto, CA 94303.

Project Description: The project would demolish the two existing buildings on-site and construct an eight-story structure with approximately 231,883 square feet of office space and a five-story, 284,094-square-foot parking structure with 773 parking spaces.
