- A. 1800 West Bayshore Road appeal:

**Public Hearing:** Appeal of Variance (V 05-34), Architectural Supervision, Conditional Use Permit (CUP 05-34) and Categorical Exemption (CE 05-76).

**Location:** 1800 West Bayshore Road, East Palo Alto, CA 94303

**Owner/Applicant:** Andrew Lesser

**Proposal:** The City Council will consider an appeal of the Planning Commission approval of Conditional Use Permit (CUP 05-34), Architectural Supervision (AS 05-34) and Variance (V 05-34) to allow the operation of a laundromat business in an existing, currently vacant building at 1800 West Bayshore Road. The proposal would allow the construction of a five hundred and twenty-six (526) square-foot addition to the northwest end of an existing three thousand (3,000) square-foot building; demolition of two hundred and seventy-nine (278.7) square feet from the southwest end of the building; minor interior remodeling; renovation of the landscape; and, the creation of additional parking. The Variance would allow: a reduction in parking spaces from the required one (1) space for every 160 square feet of floor space to one (1) space per 198 square feet; and, a reduction in the required six (6) feet setback from the southwest property line in order to accommodate the existing eight (8) inch setback.

**General Plan Land Use Designation:** Neighborhood Commercial

**Zoning/APN:** C-1/S-3 (Neighborhood Commercial) / 063-501-290

**Recommendation:** Open the hearing, take testimony, close the hearing; Deny the appeal by sustaining the Planning Commission decision
